CONSENT SCHEDULING ORDER

Pursuant to the Federal Rules of Civil Procedure and the Local Civil Rules of this Court, the following Consent Scheduling Order is established for the remaining tasks in the case. This Order is entered to administer the trial of cases in a manner consistent with the ends of justice, in the shortest possible time, and pursuant to the Court's Text Order dated July 29, 2022. ECF No. 73:

 Defendant Beaufort County shall provide class data to Plaintiffs no later than May 31, 2023.¹ Class data shall be produced in usable electronic format including name, date of arrest, last known mailing address, social security number, telephone number and email address (if any). If Defendants have no social security numbers on file, they shall provide each class member's booking number or similar unique identifier. The electronic data shall be produced in MS Excel format (.xls) or comma separate value files (.csv). Per

the Order of the Court dated July 14, 2022 (ECF No. 68), the class is as follows:

Female pre-classification detainees in the custody of BCDC who, upon their admission to BCDC, were strip/visual body cavity searched, while pre-classification males were not, from February 27, 2015, until May 5, 2020 (ECF No. 49 at 4)

- Plaintiffs, should they choose to retain one, shall by May 1, 2023, identify to
 Defendant their third-party notice administrator to assist with notice
 dissemination and other class communications to class members.
- 3. Plaintiffs shall submit their proposed Class Notice by May 31, 2023.
- 4. Plaintiffs, or their third-party notice administrator, shall send Class Notice by June 30, 2023, followed by an "opt out" period for sixty (60) days that will expire on August 29, 2023.
- Plaintiffs are authorized to provide the Class Notice using various means including, but not limited to, a website, newspaper advertising and email communications.
- Plaintiffs, or their third-party notice administrator, shall by September 29, 2023, submit a report to the Court summarizing the notice process, notices sent, opt-outs and any objectors.
- 7. Pre-trial Motions shall be due by October 16, 2023.
- 8. Trial of the case will be no sooner than November 13, 2023.
